

**“The GIANT Company LLC In-store Customer Satisfaction Survey” Sweepstakes
OFFICIAL RULES**

THE FOLLOWING SWEEPSTAKES IS INTENDED FOR PARTICIPATION IN THE UNITED STATES ONLY (SPECIFICALLY MD, NJ, PA, VA, AND WV). PLEASE DO NOT SUBMIT AN ENTRY IF YOU DO NOT MEET THE ELIGIBILITY REQUIREMENTS LISTED IN THE “ELIGIBILITY” SECTION BELOW. Void where prohibited by law. Subject to all federal, state and local laws, regulations, and ordinances.

- 1. DATES OF SWEEPSTAKES:** “The GIANT Company LLC In-store Customer Satisfaction Survey” Sweepstakes (the “Sweepstakes”) begins at 10:00 a.m. Eastern Standard Time (“EST”) on January 1, 2022 and ends at 11:59 p.m. EST on December 31, 2022 (the “Sweepstakes Period”), subject to entry periods as outlined in the “ENTRY PERIODS” section below. Online Survey computer is the official time keeping device for entering via the Online Survey. Winning a prize is contingent upon fulfilling all requirements set forth herein. All entries received after the Sweepstakes Period for the Online Survey and the received by date for the AMOE (defined below) are ineligible to win.
- 2. SPONSORS:** The GIANT Company LLC, 1149 Harrisburg Pike, Carlisle, PA 17013 (referred to herein as “Giant/Martin’s” or “Sponsor”).
- 3. ELIGIBILITY:** The Sweepstakes is open only to legal residents of Maryland, New Jersey, Pennsylvania, Virginia, or West Virginia who are eighteen (18) years of age or older at time of entry (the “Entrant”). Officers, directors, managers and employees of Sponsor and their parent subsidiaries, affiliates and related companies, dealers, advertising and promotion agencies, including companies providing marketing and market research services to Sponsors, consultants and agents, as well as the immediate family household members (spouse, parents, siblings, children or relatives) of each such person, and any others engaged in the development, production, execution or distribution of this Sweepstakes, including National Sweepstakes Company, LLC (the “Independent Administrator”) herein (collectively “Sweepstakes Entities”), are not eligible to participate. Sweepstakes is void outside of MD, PA, VA, and WV and wherever else restricted or prohibited by law.

Limit of five (5) entries per person/household per Entry Period, regardless of the method of entry. Non-Winning eligible entries from previous Entry Periods will not carry over to the next Entry Period and will not be considered eligible for subsequent drawings.

5. HOW TO ENTER: There are two (2) ways to enter the Sweepstakes; (a) the Online Survey; or (b) the AMOE. **Regardless of the method of entry, there is a limit of five (5) entries per person/household per Entry Period.**

- a. **Online Survey:** Entrants making a purchase (of any amount) at a participating Giant or Martin's retail location during the Sweepstakes Period and are the recipient of a survey invitation on their cash register receipt will need to log on to www.talktogiant.com (Giant cash register receipt) or www.talktomartins.com (Martin's cash register receipt) (the "Websites") within five (5) days from the cash register receipt date and enter the receipt number found on the cash register receipt from participating Giant/Martin's retail locations in MD, PA, VA, and WV. Then, complete the survey in its entirety and click the "Continue" button. Upon clicking the "Continue" button, Entrant will need to complete the entry form and click "Submit" to receive one (1) entry into the respective Entry Period for the Sweepstakes. Surveys must be completed within five (5) days from the cash register receipt date in order to be eligible. All online Entrants must have access to the Internet prior to the start of the Sweepstakes in order to enter via the Online Survey.
- b. **Alternate Method of Entry ("AMOE"):** To enter the Sweepstakes without purchase and/or taking the Online Survey, Entrant may enter by mail as follows: On a plain 3" x 5" card, legibly handprint or type your first name, last name, street address, city, state, zip code, telephone number (including area code), date of birth and email address (optional), and mail your 3" x 5" card in a business size envelope to: "The GIANT Company LLC In-store Customer Satisfaction Survey", PO Box 456, Newark, NY 14513. To receive an entry via AMOE, the AMOE entry must be postmarked and received by the dates outlined in the "ENTRY PERIODS" section above. Each envelope is considered one (1) entry. Multiple entries submitted in the same envelope are void. No mechanical reproductions will be accepted. Entrant may submit five (5) envelopes for each Entry Period of the Sweepstakes. Proof of sending or submission will not be deemed to be proof of receipt by Sponsors.

Neither Sponsors nor any Sweepstakes Entity are responsible for any entry that is lost, late, misdirected or undeliverable, whether through the mail or due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer or telephone transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise. Entries submitted by anyone other than the Entrant are void. Neither the Sponsors, nor Independent Administrator will verify receipt of entries for Entrants. All entries submitted become the sole property of the Sponsors and will not be returned. Sponsors are not responsible for lost, late, misdirected, illegible, damaged or postage-due mailed entries.

Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different email addresses, and /or any other methods will void that Entrant's entries and that Entrant may be disqualified from the Sweepstakes. In the event of a dispute regarding the identity of an Entrant, who enters by providing an email address, the entry will be assigned to the authorized account holder of the e-mail address submitted on the Entry Form or via the AMOE. "Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization (i.e., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

6. **WINNING/ODDS:** A drawing will be conducted on or about the drawing dates listed in the Entry Period chart above in which five (5) prize winners (each a "Prize Winner") will be randomly selected from among all eligible entries received during the respective Entry Period by the Independent Administrator. Odds of winning depend on the number of eligible entries received during the respective Entry Period. Non-winning eligible entries from the previous Entry Period will not carry over to the next Entry Period drawing. By entering the Sweepstakes, Entrants fully and unconditionally agree to be bound by these Official Rules and the decisions of the Sweepstakes Entities, which will be final and binding in all matters relating to the Sweepstakes.
7. **PRIZES:** There will be a total of five (5) Prize Winners awarded per Entry Period. Each Prize Winner will receive a \$500 gift card to Giant/ Martin's (the "Prize"). The approximate retail value (the "ARV") of each Prize to be awarded is \$500.00. The total ARV of all Prizes to be awarded per Entry Period is \$2,500.

There is a limit of one (1) Prize per Entrant/household per Entry Period. Prizes are subject to the terms and conditions as outlined on the gift card. Prizes cannot be substituted, assigned, or transferred; except at a Sponsor's sole discretion or as otherwise provided herein. Sponsors reserve the right to substitute the Prize with a prize of comparable or greater value if advertised prize should become unavailable. Sponsors will not replace any lost or stolen Prizes. Prize Winners are solely responsible for any taxes on the prize he/she has received, including but not limited to any and all federal, state and local taxes, if applicable. No more than the stated number of Prizes set forth in these Official Rules will be awarded.

8. **NOTIFICATION/PRIZE CLAIMS:** Potential Prize Winners will be notified by email, phone, and/or mail on or about two (2) business days after the drawing date for each Entry Period. Except where legally prohibited, potential Prize Winners may be required to execute and return an Affidavit of Eligibility, Liability & Publicity Release within seven (7) business days of notification receipt to claim his/her Prize or Prize may be forfeited. If a potential Prize Winner cannot be reached after two (2) attempts to contact him/her have been made, fails to sign and return the Affidavit of Eligibility, Liability & Publicity Release within the required time period, or is disqualified for any reason Sponsors will, if time allows, award the applicable Prize to an alternate Prize Winner, selected by a random drawing from all remaining non-winning eligible entries received during the respective Entry Period. Only two (2) alternate drawings will be held, after which any remaining Prizes will not be awarded.

MATTERS RELATED TO THE SWEEPSTAKES. AN ENTRANT IS NOT A PRIZE WINNER OF ANY PRIZE UNLESS AND UNTIL ENTRANT'S ELIGIBILITY HAS BEEN VERIFIED AND ENTRANT HAS BEEN NOTIFIED THAT VERIFICATION IS COMPLETE.

Sponsors and Sweepstakes Entities are not responsible for: (i) any printing or other errors in Sweepstakes related material (and they reserve the right to correct clerical or typographical errors in such materials); (ii) computer system, network, hardware, software or program malfunctions, or other errors or malfunctions of any kind whether human, mechanical, electronic, or otherwise, technical failures, or delays, garbled transmissions or miscommunications, telephone transmission problems, and (iii) damage to a user's computer equipment (software or hardware in electronic transmissions, lost, interrupted or unavailable network connections. Should any portion of the Sweepstakes be, in Sponsors' sole discretion, compromised by non-authorized human intervention or other causes which, in the sole discretion of the Sponsors, corrupt or impair the administration, security, fairness or proper submission of entries, Sponsors reserve the right, at its sole discretion, to cancel, terminate, modify or suspend the Sweepstakes and conduct the Sweepstakes in a manner which in its sole discretion is fair, appropriate and consistent with these Official Rules. Notice of such action by Sponsors will be posted at the Websites. Sponsors reserve the right in their sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner.
